


If a judgment bases its ruling on sound grounds sufficient to lead to that conclusion, then it does no wrong in not dealing with all of the arguments and points adduced by a party, as the court is not obliged to follow up each argument or to give effect to each point provided that in accepting the evidence on which it bases its judgment there is an implied response negating such arguments or points.

2.

There is no obligation on an expert to carry out his work in a particular manner. It is enough that he performs what he has been instructed to do in such a manner as he thinks fit in achieving the purpose of the instruction given to him, provided that he acts within the framework of the brief given to him, and all of the above is within the overall control of the court.


2 Compare Text
