### Workload management for lawyers

For instance, there was a case where a client provided judgements generated by ChatGPT, but those judgments did not exist, which was a significant issue," said Santanu.

#### **Creates room for more cases**

### CoCounsel removes risk of "unofficial" Al in firms

Whilst general-use AI tools are useful, Santanu is concerned about lawyers using them in the workplace unofficially, and without verifying the accuracy.

"It is crucial to ensure that AI-generated content conforms to legal requirements. There have been instances in the profession where juniors used AI for drafting, but the substance was lost despite the grammatical accuracy. This highlights the need for proper oversight and training in using general-use AI tools effectively," explained Santanu.

"Lex Ensemble's decision to roll out a trusted, professional-grade AI rules out any possible use of unofficial AI at the firm. CoCounsel allows us to drive AI innovation in a safe manner."

### Plugging in to the Thomson Reuters ecosystem

Santanu is looking forward to discovering more features as he uses CoCounsel. The potential for AI to integrate with other systems and handle more complex tasks is exciting.
